What Is A PEARL Member Types, Categories, Co-Creators

The PanTerraVida Private Contract Association has established three types of members, GEM, PEARL, and Full Member. The PEARL member status is for individuals, companies, and organizations that wish to work with the Society in professional capacities via strategic alliances, partnerships, contract relations, or as individual co-creators by contract or employee arrangements. These will involve placement in specific functions in our projects or administrative offices. This type of member status was created to accommodate those individuals and entities that are not interested in our other points of focus, but are only interested in being part of our Master Plan with their professional skills and expertise.

All such individuals and groups will be reviewed with our standard processes of interview, vetting, and confirmation that we apply for other types of members. Of course there will be unique situations that require additional or expanded processes leading to approval and contract, so these will be approached on a case-by-case basis. Regardless of type of category, all participants with the PTV Society must enter into a private contract to maintain the integrity of our jurisdiction. Individual PEARL members will be required to enter such a contract via the GEM level. This will enable them to have access to the GEM level of education, media, marketplace, and monetary accounts, but there are no other obligations attached to this status other than the specifics of each contract. An individual can enter into a private contract for services or can enter via an employment arrangement as further described below. Entities

such as organizations and companies are not required to also engage GEM level membership and will be qualified into our jurisdiction via the private contract for their services and professional functions.

In the last quarter of 2023, PTV will be activating numerous methods of outreach to expand our membership and as well to find the appropriate individuals, organization, and companies for PEARL level contracts. We will establish processes and protocols for this outreach through many different channels and methods. Once initial contact is made with interested parties, we will have an established set of procedures and protocols for the review process to see if we are a fit for such parties and if they in turn are interested to proceed forward to enter into contract with PTV.

PEARL Membership Categories:

1. Individual with Skills, Talents and Experience

This category is for individuals who can offer services using their skills, knowledge and experience in their areas of talent and expertise. Each can contract with PTV via Private Contract as a GEM or via an Employment Leasing Agency. We plan to have our own in-house Employee Leasing company in the near future, but initially we will start to work with selected Employment Leasing Agencies. The reason we will use such a set-up is because PTV does not have employees and will not ever do so, as part of retaining our true private jurisdiction and status.

But some individuals have personal reasons why they need to be an employee, so setting things up with a Employee Leasing arrangement enables such individuals to be an employee and in turn to have the agency "lease" the employee to the appropriate PTV entity. In this way the benefits and structures of the employment arrangement are there for the individual, while still being able to provide their skill and service to the Society.

Anyone wishing to use the employee arrangement will also enter into the GEM member level to have access to the gem.university site where they can start to learn about what PanTerraVida is doing and how it is different than the public and usual way of planning and executing projects. Those who do not require to establish an employee arrangement will be able to set up a direct contract as a PEARL and will also be required to enter the GEM level.

2. Groups and Small Companies who Offer Specific Services

This category is for small groups of people who offer services and functions that will be useful for the execution of our projects, whether it be supplying materials or services to assist with the completion of the task or project. The people who are involved in these groups or companies will be offered the GEM membership if they choose, but it will not be required. PTV will enter into a contract with the group or company and the company will be responsible for compensating its employees. All such contracts will be considered as PEARL level participation in PTV but with no obligations other than the specific terms





and conditions of the contract engaged. Over time we will be expanding details on how all this works as thus far it is only a conceptual framework that we have established. As with many things that have been developed and matured over the years in PanTerra, we "make it up as we go along" and refine our particulars through experience and the co-creative process.

3. Large Companies/Corporations

This category is for large companies, corporations, and other types of organizations. Our ultimate goal in pursuing the mobilization and build-out of our Master Plan is to bring most or all of our functions and project applications into the Society and to build all sectors with vertical integration as we build, expand, and mature our private economy within the sovereign jurisdiction that we have built over the last thirty years. But initially that is not possible and so strategic alliances, partnerships, joint ventures, and contract arrangements will be the avenue by which we engage with larger entities. As with companies, the individuals as part of the larger entities will be given the opportunity become GEM and PEARL members of PTV as a bonus, which as above, these people can have access to the General Education Media and many other valuable functions currently in place and continually being built. However, as with the above category, we will enter into a contract and the company will be responsible for compensating its employees.

PanTerrans Entering A Real Life (PEARL): We like acronyms! So we came up with PEARL with the above wording. It is appropriate and accurate because our primary mission and intent is that we are all walking into Life and leaving the false reality of the dying global narrative behind. So regardless of what level anyone or an entity comes into our sphere of activity as per above, we consider all to be PanTerrans and that we are all working together to enter a Real Life. We define a "Real Life" as a reality in which all Living Beings and all Life Systems are honored and respected, and what we are building is established on the principles of Honor, Respect, Integrity, and Dignity. We are building a New Reality on

these principles and our projects are about the essential things in Life that will provide everyone in this world such essentials as per our Declaration of Intention¹, so that we all live in this New Reality in Peace and all are supported and honored in their Sovereign Integrity² in Life. We look forward to working with all those who wish to join us to make such intentions and principles real.
